How does eFlow work?

User-configurable rules define when the system creates a task, to whom it is

routed, and when it moves to the next person in the cycle. Rules also recognize exceptions, manage escalations and archive completed jobs. In a Claims processing office, for example, **eFlow** rules can be set up to automatically create and assign a job when the basys system receives an electronic claim, or when an operator scans and indexes a paper claim.

How do operators access their work?

As **eFlow** creates jobs, it bundles similar tasks together in batches and automatically distributes them to operators according to your preset workflow rules and desired load balancing. Operators access their work



using **eFlow**'s Task Manager, a user-friendly electronic in-box that shows the batches they are assigned. The operator can open a batch and begin working on a job. From the job details screen, operators can launch the basys application needed to complete the job. Once completed, the job will automatically move from the operator's Task Manager to the next person in the flow.

eFlow maximizes your efficiency and minimizes operational costs by:

- Creating and routing jobs automatically and consistently based on your office's own best practices and procedures.
- + Distributing jobs equitably between operators to optimize workloads.
- Seamlessly integrating with basys applications so operators can complete jobs or so that system events trigger eFlow to create new jobs.
- Expiring jobs automatically after a defined period and routing them to a supervisor for handling.
- Connecting transparently to an optional Enterprise Content Management (ECM) system so operators can view electronic content (such as images files, email, etc.) related to jobs from within eFlow.
